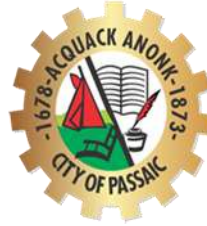

The person who makes these statements will relinquish their allotted five minutes for public discussion.*
