### INSTRUCTIONS

You have requested an application for Handicapped Parking. Please fill out the accompanying form and attach a copy of your:

- Driver's License.
- DMV Handicapped ID Card.
- State of New Jersey Vehicle Registration.

All three documents must have the applicant's address where the sign will be installed.

The application shall be submitted to the Engineering Division with your current information and a nonrefundable fee in the amount of \$75.00 for a Personalized parking space. No fee for a Generic parking space.

**NOTE:** Generic parking space applicants are hereby advised that, should the City of Passaic grant that handicap parking restriction signs be placed in close proximity to your home, it is not a guarantee that this parking space has been made available for your personal use only. This space is also available to any handicapped person living in or visiting someone in the proximity of your home according to State of New Jersey Statute 39:4-204-207.

Restricted Handicapped Parking is granted ONLY to **handicapped individuals who drive and own/lease a vehicle**. Extenuating circumstances for dependant and/or household relatives who cannot drive will be considered. The nondisabled driver must reside in the same household as the disabled person and provide verification of such status.

Restricted handicapped spaces will not be provided to applicants who have access to driveways and/or to other off street parking facilities.

Your application must be approved by the Engineering Division and by the City Administration offices, after which it will be presented to the City Council for final approval.

The Handicapped Parking Designation must be renewed on an annual basis by January. If you wish to continue this service, you must renew and pay the corresponding fee. Renewals will not automatically be given. The annual fee for a Personalized parking space shall be \$50.00. No annual fee for a Generic parking space.
