EXECUTIVE ORDER OF THE HONORABLE HECTOR C. LORA, MAYOR OF THE CITY OF PASSAIC

WHEREAS, beginning Sunday, January 31, 2021, and continuing through Tuesday, February 2, 2021, the State of New Jersey is expected to experience a major, prolonged nor'easter winter storm causing hazardous weather conditions including heavy mixed precipitation, high winds, blizzard-like conditions, coastal flooding, and total snow and ice accumulations of 12 to 18 inches in a substantial portion of the State; and

WHEREAS, the National Weather Service has issued a Winter Storm Warning for central and northern New Jersey, and a coastal flood watch for coastal areas of New Jersey over the three tide cycles from Monday morning to Tuesday midday; and

WHEREAS, snow accumulation has begun on Sunday afternoon, with the heaviest snow expected to fall during the day on Monday, exceeding one inch per hour at points, and dangerous road conditions making travel difficult to impossible beginning late Sunday night through much of Monday; and

WHEREAS, the Governor of the State of New Jersey has issued Executive Order No. 218, declaring a statewide State of Emergency due to this inclement weather; and

WHEREAS, pursuant to Chapter 15 of the City Code of the City of Passaic, the Mayor shall have the authority to declare a state of emergency within the City and shall be empowered to make to make orders and regulations as necessary to address the current state of affairs.

NOW, THEREFORE, pursuant to the authority vested in me by law as the Mayor of the City of Passaic, I, Hector C. Lora hereby ORDER as follows:

1. A state of emergency is hereby declared in the City of Passaic due to inclement weather.
2. All public buildings, roadways, parks, facilities or other public property shall be closed immediately for public use pursuant to Chapter 15-1(B) and Chapter 15-1(C) of the City Code of the City of Passaic.
3. This Executive Order shall only affect the City of Passaic and has no effect on other municipalities.

4. This Executive Order shall take effect as of 5:00 p.m. on January 31, 2021 and shall remain in effect until such time as it is determined by me that an emergency no longer exists.
5. If any provision of this Executive Order, or the application of any provision to any such person or circumstance, shall be held invalid or unenforceable for any reason, the remainder of this Executive Order to the extent it can be given effect, of the application of such provision to person or circumstance other than those to which it is held invalid or unenforceable shall not be affected thereby, and to this extent the provisions of this Executive Order are severable.
6. This Executive Order shall be kept on file in the Office of the City Clerk, published on the City's website and shall be made available to the public upon request for same.
